

# The Greater Heart of Washoe County School District

## **OFFICIAL RULES, TERMS AND CONDITIONS**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN IN THIS PROMOTION AND A PURCHASE WILL NOT INCREASE YOUR CHANCES OF SELECTION. VOID WHERE PROHIBITED BY LAW.**

**Sponsor Information:** The Greater Heart of Washoe County School District Promotion (the “Promotion”) is Sponsored by Greater Nevada Credit Union (GNCU) (“Sponsor”), PO Box 2128, Carson City, NV 89702.

**Acceptance of the Official Rules:** Please read the following Official Rules carefully. If you do not agree to the Official Rules, do not participate in this Promotion. By participating in the Promotion, each Nominator (defined below) and Winner (defined below) unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all matters related to this Promotion.

**Eligibility:** The Promotion is open to legal residents of Nevada who are eighteen (18) years of age or older at the time of entry. Nominators (defined below) and Nominees (defined below) must be an employee of Washoe County School District. Employees, officers, and directors of Sponsor, including their immediate families, may not enter or participate. Immediate family members are defined as a parent, spouse, sibling, child or anyone sharing the same residence as the applicable employee, officer or director. Employees, officers, and directors of Sponsor’s affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Promotion are also not eligible to participate in the Promotion. By participating, Nominators and Winners (defined below) agree to be bound by these Official Rules, as may be modified or amended by the Sponsor, and the decisions of the Sponsor, which are final and binding.

**How to Nominate:** The Promotion begins at 8:00 a.m. Pacific Daylight Time (“PDT”) on April 14, 2025 and ends at 5:00 p.m. PDT on April 30, 2025 (the “Nomination Period”). During the Nomination Period, any eligible person may nominate (a “Nominator”) another eligible person (a “Nominee”) to be a winner for that Nomination Period. Nominations must be submitted by visiting [www.gncu.org/WCSD](http://www.gncu.org/WCSD) and completing the online nomination form. The Nominator must provide all the required information requested in the online nomination form, including the Nominee’s telephone number and email address and how this nominee exemplifies being the Greater Heart of Washoe County School District. A Nominator may submit multiple nominations during a Nomination Period but may only submit one nomination per Nominee.

Sponsor reserves the right to disqualify nominations that contain offensive or inappropriate material which are deemed by Sponsor to be unsuitable, or which Sponsor believes would subject it to a claim or litigation. All nomination information becomes the property of Sponsor and will not be returned. Incomplete nominations will be disqualified. Sponsor has no obligation to preserve or return any nominations. By entering this Promotion, Nominators give their express permission to be contacted by Sponsor by telephone, email, overnight delivery and/or postal mail for any purpose.

**Selection of Winners and Odds:** At the end of the Nomination Period, Sponsor will review the nominations submitted by eligible Nominators during the Nomination Period and will select, in its sole and absolute discretion, between one and five of the eligible Nominees. Subject to verification and compliance with these Official Rules, the selected Nominees will become the winners (each, a "Winner").

Sponsor shall have sole judgment and control over every aspect of the Promotion and Sponsor's decisions on all matters related to the Promotion shall be final and binding in all respects. Sponsor's decisions on all matters related to the Promotion shall not be subject to challenge or appeal and such decisions shall not be subject to any limitation whatsoever, except for any limitations imposed by law. Sponsor reserves the right to establish and modify, in its sole judgment and at any time, the procedures and/or standards it will utilize for selecting a Winner. If sufficient nominations are not received during a Nomination Period, Sponsor may, in its sole and absolute discretion, decline to select a Winner for that Nomination Period. Because the number of eligible Nominees is unknown and the Sponsor has the sole and absolute discretion to select a Winner, the odds of a Nominee becoming a Winner are not reasonably calculable.

**Notification of Winners:** Sponsor will notify the selected Nominee(s) by telephone and/or email using the Nominee(s)'s telephone number and email address as provided by the Nominator (the "Notification"). In the event that any selected Nominee does not respond to the Notification within 48 hours of being contacted by Sponsor, declines to participate in the Promotion any reason, or is determined by Sponsor to be ineligible to participate in the Promotion for any reason, a disqualification will result and the Sponsor may, in its sole and absolute discretion, select an alternative Nominee from among the other nominations submitted during the Nomination Period.

Each selected Nominee may be required to submit his/her valid social security number and/or other identification to Sponsor and may be required to execute a Declaration of Eligibility and Release of Liability and, unless prohibited by law, Publicity, within two (2) days of the date of issuance. If a selected Nominee declines to return the required documents a disqualification will result and the Sponsor may, in its sole and absolute discretion, select an alternative Nominee from among the other nominations submitted during the Nomination Period. Once the Sponsor verifies each selected Nominee's eligibility and identity, and after the selected Nominee returns any required documents to Sponsor, the selected Nominee will be deemed a Winner.

**Donation & Prize:** Sponsor shall make a \$500 donation to the qualifying Washoe County School District school or classroom chosen by each Winner (the "Donation"). To qualify to receive the Donation, the recipient must not create a conflict of interest for Sponsor.

Sponsor may, in its sole and absolute discretion, decline to provide the Donation to a Winner's selected WCSD school or classroom and require that Winner to select an alternate qualifying school or classroom. No substitutions or transfers of the Donation is allowed, except at Sponsor's sole and absolute discretion. Winners are solely responsible for any costs to participate in this Promotion not specifically provided for in these Official Rules.

Winners will also receive two tickets to attend a Reno Ace's home game during the 2024 regular season at Sponsor's suite at the Greater Nevada Field (a "Prize"). The approximate retail value of a Prize is \$350. The specific Reno Ace's home game will be selected by Sponsor in its sole and absolute discretion. Sponsor will send the Prize to the Winner(s) via through email or mail. Prizes must be accepted as award. Prizes are not transferable and not redeemable for cash except at the sole discretion of Sponsor. Prizes are subject to change without notice at Sponsor's discretion, but will be substituted with a prize of equal or greater approximate retail value. Prizes are awarded "as is" with no warranty or guarantee by Sponsor. Additional costs or gratuities required to use the Prizes are the sole responsibility of the Winners. Each winner and his/her guest(s) agree to comply with all applicable ballpark and venue regulations in connection with the prize. Sponsor and the other MLB Entities reserves the right to remove or to deny entry to any Winner and/or his/her guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at the game/event/exhibition. Released Parties (as defined below) will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Reno Aces game/event/exhibition. Prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture and may invalidate the license granted by the game/event/exhibition ticket.

**Taxes:** ANY FEDERAL, STATE, AND LOCAL TAXES ASSOCIATED WITH THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. Sponsor may require Winner to complete a Form W-9, if applicable.
