Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.																									
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <div><div>◆ Social Security number</div><div>◆ Account balances</div><div>◆ Payment history</div><div>◆ Transaction or loss history</div><div>◆ Credit history</div><div>◆ Credit scores</div></div>																									
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information, the reasons Greater Nevada Credit Union chooses to share, and whether you can limit this sharing.

What We Do	
How does Greater Nevada Credit Union protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.</p>
How does Greater Nevada Credit Union collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none">◆ Open an account◆ Apply for a loan◆ Make deposits or withdrawals from your account◆ Give us your income information◆ Show your government-issued ID <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none">◆ sharing for affiliates' everyday business purposes - information about your creditworthiness◆ affiliates from using your information to market to you◆ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	<p>Your choices will apply to everyone on your account.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none">◆ <i>Our affiliates include:</i><ul style="list-style-type: none">◆ <i>Financial companies such as: Greater Nevada, LLC., Greater Nevada Financial Group, and Greater Commercial Lending</i>◆ <i>Nonfinancial companies.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none">◆ <i>Greater Nevada Credit Union does not share with nonaffiliates for marketing activities.</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none">◆ <i>Our joint marketing partners include insurance companies and financial service providers.</i>
