OFFICIAL RULES, TERMS AND CONDITIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN IN THIS PROMOTION AND A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW. The August 2025 Family Field Day Sweepstakes (the "Sweepstakes") is open to Greater Nevada Credit Union ("GNCU") members age 18 or older who are legal residents of the United States of America. Employees, officers, and directors of GNCU and SK Baseball LLC (collectively the "Sponsors"), including their immediate families, may not enter or participate. Immediate family members are defined as a parent, spouse, sibling, child, or anyone sharing the same residence as the applicable employee, officer, or director. Employees, officers, and directors of Sponsors' affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are also not eligible to participate in the Sweepstakes. By participating, entrants agree to be bound by these Official Rules, as may be modified or amended by the Sponsors, and the decisions of the Sponsor, which are final and binding.

<u>**How to Enter:**</u> The Sweepstakes begins at 12:00 a.m. Pacific Time ("<u>PT</u>") on July 14, 2025, and ends at 11:59 p.m. PT on August 3, 2025 (the "<u>Entry Period</u>"). All entries must be submitted within the Entry Period. Entries received after the end of the Entry Period will be void. Limit one (1) entry per person/email address/household. Additional entries beyond the specified limit will be void.

To register, entrants must visit <u>www.gncu.org/membership/greater-nevada-field/family-field-day/</u> and complete the online entry form. All entries must include a valid email address for the entrant. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. In case of dispute as to the identity of any entrant, each entry will be deemed made by the Authorized Account Holder (as defined below) of the email address used to enter the Promotion. "Authorized Account Holder" is defined as the natural person who is assigned to an email address by an Internet service provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

The terms and conditions of the tickets awarded as part of the Prize will govern in the event a legal game, event or exhibition, as defined by Minor League Baseball, is not played due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason.

Sponsors and the applicable Minor League Baseball Entities reserve the right to remove or to deny entry to the Winners and/or their guest(s) who engage(s) in a non-sportsmanlike or disruptive manner to annoy, abuse, threaten or harass any other person at the game, event or exhibition. Released Parties (defined below) will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any Minor League Baseball game, event or exhibition. Minor League Baseball game, event and exhibition tickets awarded as prizes

may not be resold or offered for resale. Any such resale may result in disqualification and Prize forfeiture, and may invalidate the license granted by the game, event or exhibition ticket(s).
