Greater Nevada Members 25 Years and Older

Scholarship Application Information for the 2026-2027 Academic Year

Greater Nevada Credit Union (Greater Nevada) has established an additional scholarship program for members aged 25 and over to continue their education past high school during the 2026-2027 school year. **Applicants must be a Greater Nevada member and have a valid account number.** Greater Nevada employees, volunteers, directors, committee members, and their families are not eligible for this program. Successful applicants will be limited to receiving one lifetime scholarship from Greater Nevada.

Scholarships in the amount of \$2,000 will be awarded to applicants seeking an undergraduate degree; post-graduate programs are not eligible, such as master's and doctoral programs. Selection criteria will be based primarily on the financial need of the applicant. Awards will be made on a competitive basis; all scholarship decisions will be made at the sole discretion of the Greater Nevada Scholarship Committee.

- Applicants are not limited to attending Nevada schools. Post high school institutions such as technical schools, colleges, educational institutions including universities, schools, community/junior schools, accredited trade and vocational schools are eligible, providing the recipient is enrolled in classes that fulfill the 9 credits per semester criteria. Recipients must earn a minimum of **18 credits** per academic year, Fall and Spring semesters, and maintain enrollment throughout each semester.
- Scholarship funds will be paid in two \$1,000 installments (Fall and Spring), directly to the school of the recipient's choice once enrollment has been confirmed by Greater Nevada. Scholarship funds may not be carried over into a succeeding school year. Recipients will be limited to receiving only one scholarship and will not be eligible for this program in subsequent years. However, Greater Nevada may, at its discretion, award a second continuing scholarship to a student who has had a successful preceding academic year and has demonstrated financial need.
- Scholarship monies may be used for tuition, course registration, special class or laboratory fees, room and board, textbooks, and class materials.

Required information to be submitted with the completed application:

1. Personal statement
2. Copy of most recent school transcripts (college, high school, or GED verification)
3. Minimum of two (2) letters of recommendation, preferably dated 2025 to 2026, **from school, employer, and community leaders.** (letters authored by family members will not be considered)

Applications with the required information listed above can be submitted electronically at www.gncu.org, mailed, or hand delivered by **5:00 p.m. PT on Friday, March 20, 2026**. Any mailed applications are exempt from the 5:00 p.m. time requirement but must be postmarked by Friday, March 20, 2026. 1. If you decide to apply, please be sure to complete the entire application starting on page three of this document packet, SECTION II. All pages of the scholarship information and application packet (pages 1 through 5) must be returned with the required information listed below in steps 2, 3, and 4.
2. Include a personal statement of not more than two pages in length. The statement can be typed or handwritten. The statement should describe your interests in community activities, career, work experience, and any barriers you have encountered in attempting to attend school.
3. Copy of your most recent college/high school transcript, or GED verification.
4. Minimum of two (2) current letters of recommendation from employers or community leaders.

The deadline for this application is Friday, March 20, 2026, by 5:00 p.m. PT. Please submit a complete application with the required information electronically through the Greater Nevada website at www.gncu.org, or mail it to the following address:

Your signature on page five (5) of this application acknowledges you understand that this application will not be considered without your personal statement, previous academic performance (college/high school transcript or GED verification), and two (2) current letters of recommendation included with the completed application. Please prepare your application and personal statement carefully and neatly.

Applicants will be notified of the status of their applications by June 1, 2026. Applicant interviews may be required via telephone or in-person if additional information is needed. All applicants must be a minimum of 25 years of age by Friday, March 20, 2026.
